



## Timeshare Auction

### ***Frequently Asked Questions:***

Will ALL the units inside Tropic Shores be affected?

No, only the timeshare units that have been notified regarding a foreclosure due to delinquent maintenance fees will be sold. These units are listed in the included table.

How may I participate in the auction?

(1) In person:

You or a representative must be present and provide proof of funds in the form of cash, cashier's check, or money order. You will be allowed to leave the auction after winning your bid to retrieve funds. Upon the sale, payment in full must be made on the auction day to the Trustee, Fresh-Start.Law, P.A.

(2) Appearing Telephonically:

In order to appear via phone, you must contact the Trustee and have transmitted to Tropic Shores **a cashier's check or money order** in your desired maximum bid amount\* prior to **Thursday, May 16, 2024**. We cannot accept funds after May 16, 2024. You will be required to call, on the day and exact time of the auction, a telephone number that will be provided to you via email. You will be on speakerphone and will participate in the auction as if you were in the room. Any excess funds you have mailed to Tropic Shores will be promptly returned to you within 3-4 business days.

\*Please note that if the bid amount transmitted to Tropic Shores is not enough to cover the highest bid, you will not be able to purchase that timeshare. Any funds held by Tropic Shores will then be disbursed back to you within 3-4 business days.

What does prime vs preferred mean?

Prime units are available at any time except during weeks 6 & 7 when they are based upon availability. Preferred can book weeks 1-4, 38-45, 47-50.

Does the sale price include maintenance fees for 2024?

No, it does not. You may use your unit in 2024, subject to availability, if you pay the 2024 maintenance fees. Maintenance fees range from \$588.80 to \$750.50 depending on the number of bedrooms and the week. See the front desk for more information on 2024 maintenance fees. You do not need to pay 2024 maintenance fees if you do not use the unit in 2024.

Are there any closing costs or additional costs not covered in the final sale price?

No, there are no closing costs or additional costs.
